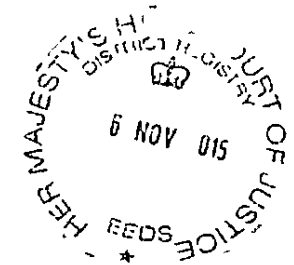

**ORDER**

**UPON** the adjourned application and petition of Barclays Bank plc presented to this court on 15 January 2015

**AND UPON** the Third Respondent's application to rescind/set aside the Order of District Judge Troy of 10 March 2015 that Client Connection Limited ("the Company") be restored to the Register

**AND UPON HEARING** Counsel for the Petitioner and Counsel for the Third Respondent, the former administrator of the Company

**AND UPON READING** the evidence

**IT IS ORDERED THAT:**

1. The Third Respondent's application to rescind/set aside the Order of District Judge Troy of 10 March 2015 is dismissed such that the restoration of the Company to the Register pursuant to section 1031(2) of the Companies Act 2006 do stand;
2. Client Connection Limited be wound up by this court under the provisions of the Insolvency Act 1986;

And the Court being satisfied on the evidence that the EC Regulation does apply and that these proceedings are main proceedings as defined in Article 3 of the EC Regulation

**AND UPON READING** the written submissions dated 8 and 15 October 2015 in relation to costs

**IT IS ORDERED THAT**

3. The Petitioner's costs be assessed at £9218.00 + VAT and be paid as follows:
  - 3.1 The Third Respondent should by 4.00pm on 16 November 2015 pay to the Petitioner the sum of £3875.00 + VAT (i.e. £4,650)
  - 3.2 The balance of the Petitioner's costs (i.e. £6,411.60) shall be treated as costs of the petition and paid as an expense of the liquidation.
