ORDER

**UPON** the application of Stephen Mark Powell ("the **Application**")

**AND UPON** reading the witness statements of Sally Richards and Stephen Mark Powell

**IT IS ORDERED THAT:**

1. The insolvency proceedings listed in the Schedules attached hereto which are not currently before the High Court of Justice ("**High Court**") be transferred to the High Court for the purposes of the Application only, and the Applicant does ensure that a sealed copy of this Order be lodged with the Court having jurisdiction over each case affected by this Order.

2. The First Respondent, Sally Richards, is removed from her office as Administrator in respect of the companies in Administration which are set out in Schedule A attached hereto.
3. The Applicant, Stephen Mark Powell, is appointed as Administrator in substitution of the First Respondent in respect of the companies which are set out in Schedule A attached hereto. In the event that the said companies go into voluntary liquidation the Court hereby appoints Stephen Mark Powell to be a liquidator with effect from the date of liquidation. For the avoidance of doubt, nothing in the Order shall prevent the creditors of the companies from seeking to exercise their power to nominate another person as proposed liquidator pursuant to paragraph 83(7)(a) of Schedule B1 of the Insolvency Act 1986, or section 139(3) of the Insolvency Act 1986.
4. The First Respondent, Sally Richards, is removed from her office as Administrator in respect of the limited liability partnership in Administration which is set out in Schedule B attached hereto.
5. The Applicant, Stephen Mark Powell, is appointed as Administrator in substitution of the First Respondent in respect of the limited liability partnership which is set out in Schedule B attached hereto. In the event that the said limited liability partnership goes into voluntary liquidation the Court hereby appoints Stephen Mark Powell to be a liquidator with effect from the date of liquidation. For the avoidance of doubt, nothing in the Order shall prevent the creditors of that limited liability partnership from seeking to exercise their power to nominate another person as proposed liquidator pursuant to paragraph 83(7)(a) of Schedule B1 of the Insolvency Act 1986, or section 139(3) of the Insolvency Act 1986 (as amended by the Insolvent Partnerships Order 1994).
6. The First Respondent, Sally Richards, is removed from her office as Liquidator in respect of the companies in Creditors' Voluntary Liquidation which are set out in Schedule C attached hereto.
7. The Applicant, Stephen Mark Powell, is appointed as Liquidator in substitution of the First Respondent in respect of the companies which are set out in Schedule C attached hereto.
8. The First Respondent, Sally Richards, is removed from her office as Liquidator in respect of the limited liability partnerships in Creditors' Voluntary Liquidation which are set out in Schedule D attached hereto.
9. The Applicant, Stephen Mark Powell, is appointed as Liquidator in substitution of the First Respondent in respect of the limited liability partnerships which are set out in Schedule D attached hereto.
10. The First Respondent, Sally Richards, is removed from her office as Liquidator in respect of the companies in Members' Voluntary Liquidation which are set out in Schedule E attached hereto.
11. The Applicant, Stephen Mark Powell, is appointed as Liquidator in substitution of the First Respondent in respect of the companies which are set out in Schedule E attached hereto.
12. The First Respondent, Sally Richards, is removed from her office as Liquidator in respect of the companies in Compulsory Liquidation which are set out in Schedule F attached hereto.

13. The Applicant, Stephen Mark Powell, is appointed as Liquidator in substitution of the First Respondent in respect of the companies which are set out in Schedule F attached hereto.
14. The First Respondent, Sally Richards, is removed from her office as Supervisor in respect of the company in Company Voluntary Arrangement which is set out in Schedule G attached hereto.
15. The Applicant, Stephen Mark Powell, is appointed as Supervisor in substitution of the First Respondent in respect of the company in a Company Voluntary Arrangement which is set out in Schedule G attached hereto.
16. The First Respondent, Sally Richards, be removed from her office as Trustee in Bankruptcy in respect of the individuals who are set out in Schedule H attached hereto.
17. The Applicant, Stephen Mark Powell, shall be appointed as Trustee in Bankruptcy in substitution of the First Respondent in respect of the individuals who are set out in Schedule H attached hereto.
18. The First Respondent, Sally Richards, be removed from her office as Supervisor in respect of the Individual Voluntary Arrangements which are set out in Schedule I attached hereto.
19. The Applicant, Stephen Mark Powell, shall be appointed as Supervisor in substitution of the First Respondent in respect of the Individual Voluntary Arrangements which are set out in Schedule I attached hereto.
20. The Applicant shall procure that, at the first convenient opportunity to do so, and in any event within 3 months of the date of the Order, a block advertisement in respect of each of the insolvency appointments listed in Schedules A, B, C, D, E, F, G, H and I shall be placed in the London Gazette containing notification of the following matters:
  - 20.1 the removal of the First Respondent and the substitution of the First Respondent by the Applicant;
  - 20.2 that creditors (and members in the case of Members' Voluntary Liquidations) and debtors have liberty to apply, within 28 days after the notice has been advertised, to vary or discharge the Order;
  - 20.3 that creditors (and members in the case of Members' Voluntary Liquidations) and debtors have liberty to apply within 28 days after the notice has been advertised, to object to the First Respondent's release;
  - 20.4 that in the case of the Liquidations and Bankruptcies listed in Schedules C, D, E, F and H, the First Respondent will be entitled to apply to the Secretary of State for her release upon the expiry of 42 days from the date the notice has been advertised, SAVE that in the event that an application in relation to one of the insolvency appointments has been made by a creditor, a member in the case of Members' Voluntary Liquidations, or a debtor, within the relevant time period, objecting to the said release, the First Respondent will not seek to apply for her release in relation to that insolvency appointment until after the said application has been disposed of (whether by agreement or by order of the Court); and

- 20.5 that in the case of the Administrations and Voluntary Arrangements listed in Schedules A, B, G and I, the First Respondent will be released from all liability both in respect of any of her acts and omissions in relation to her conduct as office-holder of the estates with effect from 28 days from the date when the notice has been advertised, SAVE that in the event that an application in relation to one of the insolvency appointments has been made by a creditor or debtor, within the relevant time period, objecting to the said release, the First Respondent will be released in relation to the said insolvency appointment 28 days after the said application has been disposed of (whether by agreement or by order of the Court) or further order of the Court in the meantime.
21. In relation to the insolvency proceedings listed in the Schedules hereto, and insofar as the Insolvency Act 1986 or the Insolvency (England and Wales) Rules 2016 contain any requirement for advertisement of the removal of the First Respondent or her substitution by the Applicant, compliance with paragraph 20 above shall be deemed as being sufficient compliance with any such advertisement provisions and for the avoidance of doubt, any further compliance with such notice provisions shall be waived. Insofar as the First Respondent is required by law to give any notice of her removal from office, the Applicant is entitled to sign and send any such notice on her behalf.
22. The period to be covered by progress reports to members and/or creditors and the dates by which those reports need to be sent to members and/or creditors and filed with the Registrar of Companies (if applicable) shall not be altered by virtue of the making of the Order or the replacement of the First Respondent by the Applicant, pursuant to this Order; and for the avoidance of doubt, any such requirement necessitating an alteration in the reporting dates by reason of the date of commencement, termination or replacement of an office holder's appointment, are hereby waived.
23. In each of the Liquidations and Bankruptcies listed in Schedules C, D, E, F and H attached hereto, the First Respondent shall be at liberty to apply to the Secretary of State for her release upon the expiry of 42 days from the date when the relevant notice referred to in paragraph 20 above has been placed in the London Gazette, SAVE that in the event that an application in relation to one of the insolvency appointments has been made by a creditor, a member in the case of Member's Voluntary Liquidations, or a debtor, within the relevant time period, objecting to the said release, the First Respondent will not seek to apply for her release in relation to that insolvency appointment until after the said application has been disposed of (whether by agreement or by order of the Court).
24. In each of the Administrations and Voluntary Arrangements listed in Schedules A, B, G and I attached hereto, the First Respondent be released from all liability both in respect of any of her acts and omissions in relation to her conduct as office-holder of the estates with effect from 28 days from the date when the relevant notice referred to in paragraph 20 above has been placed in the London Gazette, SAVE that in the event that an application in relation to one of the insolvency appointments has been made by a creditor or debtor, within the relevant time period, objecting to the said release, the First Respondent will be released in relation to the said insolvency appointment 28 days after the said application has been disposed of (whether by agreement or by order of the Court) or further order of the Court in the meantime.

25. In respect of all the companies and limited liability partnership in administration listed in Schedules A and B respectively, and solely for the purposes of rule 12.37(5) Insolvency (England and Wales) Rules 2016, the Second Respondent be treated as being joined as an Applicant for the purpose of seeking the replacement of the First Respondent.
26. The costs of and occasioned by the Application shall be paid by Begbies Traynor (Central) LLP.
27. There be liberty to apply.
