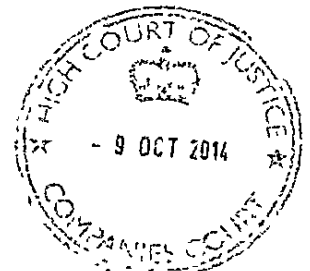

AND UPON the parties (through their respective legal representatives) agreeing the terms of this Order

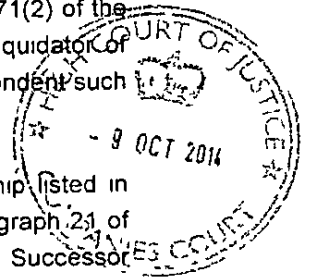
IT IS BY CONSENT ORDERED THAT

1 The cases listed in Schedules A to D attached to this Order, in so far as there are



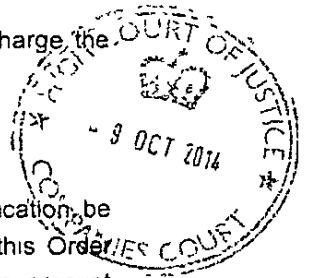
currently proceedings in the County Court or in a District Registry be transferred to the High Court in London for the purpose of making the Orders listed below

- 2 The Respondent be removed from office as Trustee in Bankruptcy of each of the individuals listed in Schedule A to this Order with immediate effect pursuant to section 298(1) of the Insolvency Act 1986 and Kevin John Hellard of Grant Thornton UK LLP, 30 Finsbury Square, London EC2P 2YU ("**Successor Practitioner**") be appointed as the Trustee in Bankruptcy of the individuals listed in Schedule A to this Order in place of the Respondent such appointments to take effect from the date of this Order
- 3 The Respondent be removed from office as the Supervisor of each of the companies listed in Schedule B to this Order with immediate effect pursuant to section 7(5) of the Insolvency Act 1986 and the Successor Practitioner be appointed as the Supervisor of each of the companies listed in Schedule B to this Order in place of the Respondent such appointments to take effect from the date of this Order
- 4 The Respondent be removed from office as the Liquidator of each of the companies listed in Schedule C to this Order with immediate effect pursuant to section 171(2) of the Insolvency Act 1986 and the Successor Practitioner be appointed as the Liquidator of each of the companies listed in Schedule C to this Order in place of the Respondent such appointments to take effect from the date of this Order
- 5 The Respondent be removed from office as the Liquidator of the partnership listed in Schedule D to this Order with immediate effect pursuant to paragraph 21 of Schedule 4 to the Insolvent Partnerships Order 1994/2421 and the Successor Practitioner be appointed as the Liquidator of the partnership listed in Schedule D to this Order in place of the Respondent such appointment to take effect from the date of this Order
- 6 The Respondent be granted her release from office as the office holder in each of the cases listed in Schedules A to D to this Order with immediate effect
- 7 Rules 4 49C(3)(a) and 6 78A(4) of the Insolvency Rules 1986 shall not apply as a consequence of this Order
- 8 The Successor Practitioner shall give notice of his appointment to all creditors of the estates listed in Schedules A, C and D (inclusive) to this Order within 28 days of the date of this Order by way of advertisement in the London Gazette
- 9 The Successor Practitioner shall give notice of his appointment to all creditors of the estates listed in Schedule B by first class post within 28 days of the date of this Order
- 10 All creditors of the estates listed in Schedules A, C and D to this Order do have permission to apply to the Court, on Notice to the Successor Practitioner within 28 days of the advertisement referred to in paragraph 8 for the purpose of applying to vary or discharge the Order insofar as it affects the estate or estates of which they are a creditor
- 11 All creditors of the estates listed in Schedule B to this Order do have permission to apply to the Court, on Notice to the Successor Practitioner, within 28 days of the posting of the



notice referred to in paragraph 9 for the purpose of applying to vary or discharge the Order insofar as it affects the estate or estates of which they are a creditor

- 12 The time for service of the Application Notice upon the Respondent be abridged
- 13 There be no Order as to costs save that the Applicant's costs of this Application be charged as a cost or expense of the estates listed in Schedules A to D to this Order (each estate to bear an equal share but with no estate having to bear an amount exceeding 10% of the available funds of that estate)
