

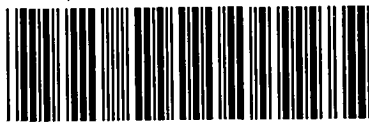

The directors are responsible for preparing the Directors' Report and the financial statements in accordance with applicable law and regulations.




For the year ended 31 December 2013 the company was entitled to exemption from audit under section 480 of the Companies Act 2006 relating to dormant companies.

### 6 ULTIMATE HOLDING COMPANY

The company's immediate parent undertaking is Glass's Information Services Limited.
