"Aims of the Company

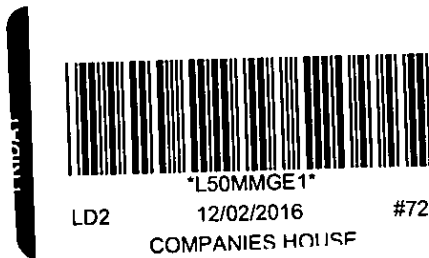
