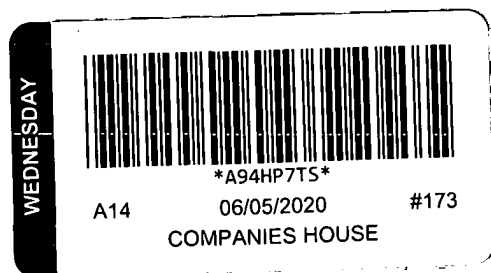




Note 1: Investment represents a 100% interest in the share capital of Destrier Partners Limited, a company incorporated in England & Wales.
