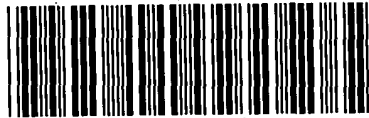


A profit and loss account has not been produced as the company did not trade during the financial year or the preceding financial year making neither a profit nor a loss.
