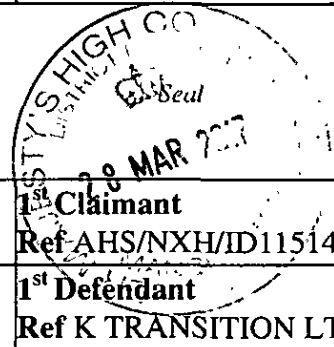

- 2) the company will continue in Members' Voluntary Liquidation
- 3) the Claimant do serve a copy of the Order on the Company's former Liquidator within 21 days of the date hereof
