

Opinion



Notes to the Financial Statements

For the year ended 31 March 2020

1 Accounting policies

Company information

Nucleus Asset Finance Limited is a private company limited by shares domiciled and incorporated in England and Wales. The registered office is 2 Gees Court, London, United Kingdom, W1U 1JA.

1.1 Accounting convention

These financial statements have been prepared in accordance with Section 1A of FRS 102 "The Financial Reporting Standard applicable in the UK and Republic of Ireland" ("FRS 102") and the requirements of the Companies Act 2006 as applicable to companies subject to the small companies regime.

The financial statements are prepared in sterling, which is the functional currency of the company. Monetary amounts in these financial statements are rounded to the nearest pound.

The financial statements have been prepared under the historical cost convention. The principal accounting policies adopted are set out below.

1.2 Going concern

As at 31 March 2020, the company had net liabilities of £7,971 and incurred a loss of £3,162 for the year ended 31 March 2020. The company is a subsidiary of Nucleus Commercial Holdings Limited. As at 31 March 2020, the group had net assets of £1,999,980 and made a loss of £3,123,316 for the year ended 31 March 2020. The group is funded through long-term credit facilities with third party lenders and the amount owed at 31 March 2020 was £84,183,699. The Director has confirmed that the profitable entities generating surplus cash will continue to support the loss-making entities within the group, for at least one year from the date of approval of the accounts. As such the accounts have been prepared on a going concern basis.

In March 2020 the World Health Organization declared the outbreak of a novel coronavirus (COVID-19) as a global health pandemic, which has spread throughout the UK. Global markets and economies have experienced a significant amount of volatility as a result of the pandemic. While the disruption is currently expected to be temporary, there is uncertainty around the duration around future cash flows and debtor recoverability. The related financial impact of this matter cannot be reasonably estimated at this time, though the director does not believe it will have material impact on the business. This is an area of continued, active management focus in respect of adjusted actions or investments that may become commercially prudent.

1.3 Cash and cash equivalents

Cash and cash equivalents include cash in hand, deposits held at call with banks and other short-term liquid investments with original maturities of three months or less.

1.4 Financial instruments

Basic financial assets are measured at cost. The company has no other financial instruments or basic financial instruments measured at fair value.

1.5 Equity instruments

Equity instruments issued by the company are recorded at the proceeds received, net of direct issue costs. Dividends payable on equity instruments are recognised as liabilities once they are no longer at the discretion of the company.

2 Employees

There were no persons employed by the company during the year or the comparative period.
