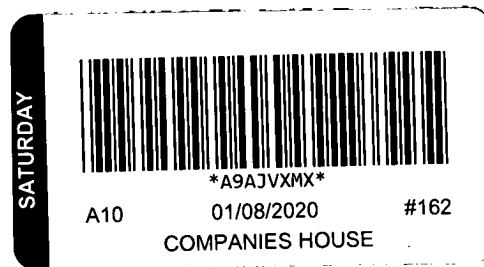

STRATEGIC REPORT
FOR THE YEAR ENDED 31 OCTOBER 2019

The Director present the strategic report, the directors' report and the audited financial statements for the year ended 31 October 2019 for KAO Corporate Limited ("the Company").

Principal Activity and Review of the Business

The Company is a private company, limited by shares in England, registration number 7842749. Throughout the year the principal activity of the Company was to be a corporate member of AKO Capital LLP. The loss for the financial year ended 31 October 2019, as detailed on page 6, was £(39,152), (2018 loss: £47,973). The Company's balance sheet as detailed on page 7 shows a satisfactory position, shareholders' funds amount to £69,214 (2018: £124,366).

Principal Risks and Uncertainties

The Director has overall responsibility for the establishment and oversight of the Company's risk management framework. The Company's Director is responsible to identify and analyse the risks faced by the Company, to set appropriate risk limits and controls, and to monitor risks and adherence to limits.

The Company's principal risks and uncertainties are the fluctuation of profit appropriations from its investment and the impairment of the value of its investment.

Going Concern

Whilst the director does not envisage the company undertaking the business for which it was originally established during the next financial year, the Company has adequate financial resources and as a consequence, the Director believes that it is well placed to manage its business risks successfully.

The Director, does not envisage the company undertaking the business for which it was originally established during the next financial year, has a reasonable expectation that the Company will continue to have adequate resources to continue in operational existence and meet its liabilities as they fall due for the foreseeable future. Accordingly, the Director continues to adopt the going concern basis in preparing the Director's report and financial statements.

Opinion

1. Principal Accounting Policies

Basis of accounting

The financial statements have been prepared in accordance with the provisions of FRS 102 Section 1A small entities. There have been no material departures from that standard. A summary of the more important standards is set out below.

The principal accounting policies adopted in the preparation of the financial statements are set out below.

As disclosed in the director's report, the Director has a reasonable expectation that the Company will be able to meet its liabilities as they fall due for the foreseeable future. For this reason the financial statements are prepared on the going concern basis.

Investments

Investments are stated at cost unless in the opinion of the Director, there has been a permanent diminution in the value of the investments, in which case they are written down to the net realisable value. Gains or losses arising on the disposal of investments are recognised within the revenue reserve. Unrealised gains or losses are recognised within the unrealised revenue reserve.

Income is included in the financial statements where declared and payable before the balance sheet date.

Taxation and deferred taxation

Current income tax assets and liabilities for the current and prior periods are measured at the amount expected to be recovered from or paid to the taxation authorities. The tax rates and tax laws used to compute the amount are those that are enacted or substantively enacted, by the reporting date, in the country where the Company operates and generates taxable income.

Deferred tax is recognised in respect of all timing differences that have originated but not reversed at the balance sheet date where transactions or events have occurred at the date that they will result in an obligation to pay more, or a right to pay less or receive more, tax.

Deferred tax assets are recognised only to the extent that the Directors consider that it is more likely than not that there will be suitable taxable profits from which the future reversal of the underlying timing difference can be deducted.

Deferred tax is measured on an undiscounted basis at the tax rates that are expected to apply in the years in which timing differences reverse, based on tax rates and laws enacted at the balance sheet date.

Revenue recognition

Revenue is recognised to the extent that the company obtains the right to consideration and is measured at the fair value of the consideration received, excluding VAT.

Dividend

Dividends are recognised as a liability in the accounting period in which they are proposed and declared.

Foreign Currencies

Transactions in foreign currencies are recorded using the rate of exchange at the date of the transaction. Assets and liabilities denominated in foreign currencies are translated using the rate of exchange at the net asset statement date and the gains and losses on translation are recognised within the profit and loss account.

2. Turnover

Turnover is attributable to profit appropriations from AKO Capital LLP and arose entirely within the United Kingdom. Turnover is recognised on an accruals basis.
