### 1 Accounting policies

#### 1.1 Accounting convention

The financial statements are prepared under the historical cost convention and in accordance with the Financial Reporting Standard for Smaller Entities (effective January 2007).

The outstanding liabilities in terms of services purchased on behalf of the Principal have been included in other creditors. The outstanding receipts in relation to sales made on behalf of the Principal have been included in other debtors.

#### 1.2 Turnover

Turnover represents amounts receivable for services rendered net of VAT.

#### 1.3 Foreign currency translation

Monetary assets and liabilities denominated in foreign currencies are translated into sterling at the rates of exchange ruling at the balance sheet date. Transactions in foreign currencies are recorded at the rate ruling at the date of the transaction. All differences are taken to profit and loss account.
