The Petition of **Hartlepool Borough Council** whose Registered Office is situate at R/O Civic Centre, Victoria Road, Hartlepool, TS24 8AY (hereinafter called "The Petitioner").

1. **RJB Coatings Ltd** (hereinafter called "the Company") was incorporated on 09 April 2008 under the Companies Act 1985. The Company is registered at Companies House under number 06560662.
2. The registered office of the Company is at Flannagans Accountants, 7 Bankside, The Watermark, Gateshead, NE11 9SY.
3. The nominal capital of the Company is £100 divided into 100 shares of £1.00 each. The amount of the capital paid up or credited as paid up is £100.
4. The principal objects for which the Company was established are as follows:- To carry on a business of a general commercial property, to acquire by purchase, lease, exchange, hire or otherwise, and other objects stated in the Memorandum of Association of the Company.
5. The company is indebted to the Petitioner in the sum of £11,712.05 in respect of Liability orders obtained by the Petitioner against the Company at the Teesside/Hartlepool Magistrates' Court for unpaid National Non-Domestic Rate arrears. The debt started to accrue on 01 April 2018. Attached at "Annex 1" is a statement of account.
6. The grounds upon which the Petition is based are that a written demand for payment was sent to the Company at its registered office on 04 July 2019 and the Company has failed to comply with the written demand.
7. The Company is not an undertaking within the meaning of the EC Regulation on Insolvency Proceedings.

8. For the reasons stated in the statement of truth of Alexandra Fay Ottley filed in support hereof it is considered that the EC Regulation on Insolvency Proceedings will apply and that these proceedings will be Main Proceedings as defined in the Regulation on Insolvency Proceedings.
9. The amount of the said debt remains unpaid and unsatisfied and such sum is justly due and owing to the Petitioner.
10. The Company is insolvent and unable to pay its debts.
11. In the circumstances it is just and equitable that the Company should be wound up under the provisions of the Insolvency Act 1986.

The Petitioner therefore prays as follows:-

- (1) that **RJB Coatings Ltd** may be wound up by the Court under the provisions of the Insolvency Act 1986 or
- (2) that such other Order may be made as the Court thinks fit.

Note.- It is intended to serve this Petition on the Company.


