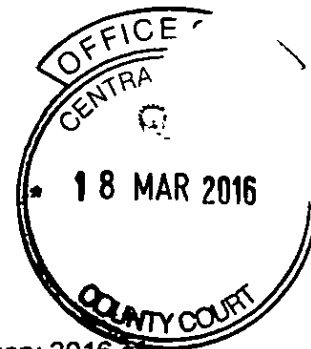

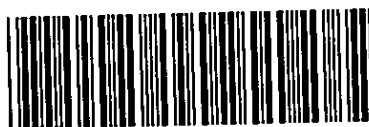
AND upon the Claimant by its Solicitors undertaking to
