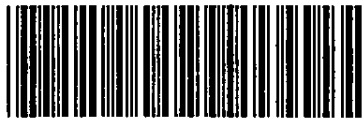

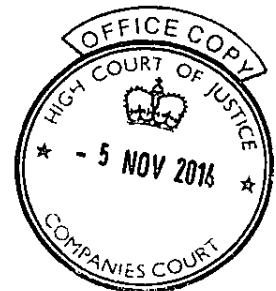

AND UPON the solicitors for the Claimant and for the Registrar of Companies (the Defendant) both consenting to this Order



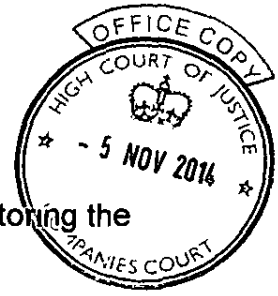
## IT IS ORDERED THAT:

- (1) the name of the above named 00266909 Limited be restored to the Register of Companies
- (2) an Office Copy of the Order be delivered to the Registrar of Companies and pursuant to the above mentioned Act the Company is thereupon to be deemed to have continued in existence as if its name had not been struck off
- (3) the Registrar of Companies do advertise notice of this Order in his official name in the "London Gazette"
- (4) in the event that the Claimant fail to comply with undertaking (C) above the Registrar of Companies be at liberty to commence strike off action in respect of the Company without further notice to the Claimant
- (5) the hearing fixed for the 19<sup>th</sup> December 2014 be vacated
