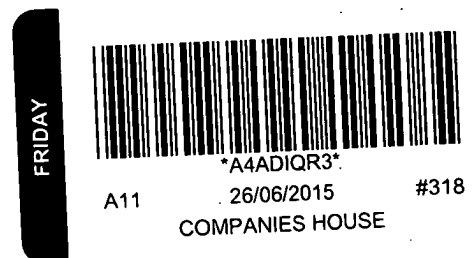

#### REPORT OF THE DIRECTORS

The Directors present their report together with the financial statements for the year ended 30 September 2014.

#### **Principal Activities**

The company is principally engaged in the management of various commercial activities of the Elim Foursquare Gospel Alliance, such as the administration of insurances and the running of conferences for the same organisation. For the financial year to September 2015 in celebration of the Elim Centenary, the annual Bible Week will be dissolved into a series of regional events and a National Leaders Conference.

We continue to use the services of Congregational and General as our main church and general insurers with support from other companies on more specialised requirements. The company continued its activity in the provision of property development services, including architectural design, planning consultation, and project management, to churches.

#### **Business Review**

The operating profit for the year amounted to £36,370 ( 2013: £29,902).

- have been prepared in accordance with the requirements of the Companies Act 2006.



**BASIS OF PREPARATION**

The financial statements have been prepared under the historical cost convention and on a going concern basis. (See note 13)

The financial statements have been prepared under the historical cost convention, and in accordance with the Financial Reporting Standard for Smaller Entities (effective April 2008)

**TURNOVER**

Turnover is the amount receivable by the company for goods supplied and services provided, excluding VAT.

**DEPRECIATION**

Depreciation is calculated so as to write off the cost of an asset, less its estimated value over the useful economic life of that asset as follows

Computer Equipment	-	25% straight line
Furniture, Fixtures and Equipment	-	25% straight line

Tangible fixed assets are stated at cost, net of depreciation and any provision for impairment.

**PENSION COSTS**

The company operates a defined contribution scheme for employees. The assets of the scheme are held separately from those of the company. The annual contributions payable are charged to the profit and loss account.

The insurance contract is administered on a centralised basis.
