

UPON THE PETITION of UC Group Limited (in administration) ("the Company") whose registered office is situate at PricewaterhouseCoopers, Plumtree Court, London EC4A 4HT presented to the Court on 24<sup>th</sup> July 2002 ("the Petition") by its Joint Administrators, David James Waterhouse and James Richard Tickell ("the Applicants").

IT IS ORDERED that:

1. The Administration Order dated 20<sup>th</sup> March 2002 be discharged pursuant to section 18 of the Insolvency Act 1986 ("the Act").

2. The Applicants be released as Joint Administrators pursuant to section 20 of the Act 14 days after they have submitted the requisite accounts of the receipts and payments of the Company pursuant to rule 2.52(1) of the Insolvency Rules 1986.
