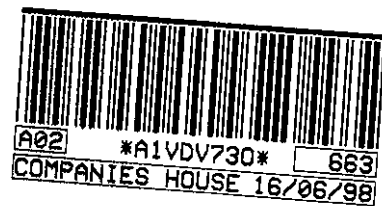

Waterlow Secretaries Limited (appointed 25 April 1997, resigned 6 June 1997).


### Directors' responsibilities for the financial statements
