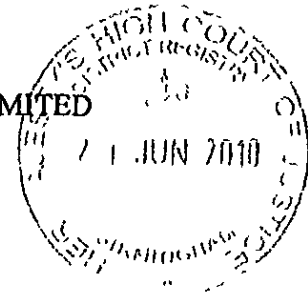

IT IS ORDERED THAT:

1. The error in naming the petitioning creditor as "*Mark Elijah Thomas Bowen (Administrator of Merthyr Tydfil Football Club Limited)*" rather than "*Merthyr Tydfil Football Club Limited, acting by its administrator*" is hereby waived pursuant to rule 7 55 of the Insolvency Rules 1986.
2. Advertisement of the Petition is dispensed with.
3. The appointment of Mark Elijah Thomas Bowen as administrator of the Company shall cease with immediate effect pursuant to paragraph 79(1) of Schedule B1 of the Insolvency Act 1986.
4. The Company be wound up under the provisions of the Insolvency Act 1986.


