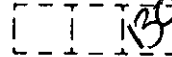





### Notes
