

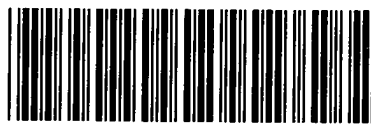


The company has been dormant throughout the year. The directors' do not anticipate any change to the company's non-trading status in the future.
