AND UPON reading the evidence and the documents on the court file

IT IS ORDERED THAT:-

1. So far as necessary for the purposes of the Application each of the appointments listed on Appendices 1 to 6 as annexed to this Order (collectively "the Appointments") be transferred to the High Court of Justice, Chancery Division, Liverpool District Registry.
2. The Applicant be removed as Liquidator of the companies in creditors voluntary liquidation on Appendix 1 annexed hereto pursuant to section 108 (2) of the Insolvency Act 1986 ("the Act") and that David Riley of RSM Robson Rhodes, Colwyn Chambers, 19 York Street, Manchester, M2 3BA ("Mr Riley") be appointed in substitution.

3. Pursuant to Sections 172(2) and 168(3) of the Act the Applicant be removed as Liquidator of the companies on Appendices 2 and 3 annexed hereto and that Mr Riley be appointed in substitution in respect of the company on Appendix 2 and that <sup>Kevin</sup> Keith Hellard of RSM Robson Rhodes, 30 Finsbury Square, London, EC2P 2XB <sup>240</sup> ("Mr Hellard") be appointed in substitution in respect of the company on Appendix 3.
4. The Applicant be removed as Administrator of the companies in Administration on Appendix 4 annexed hereto pursuant to Section 19 of the Act and that Mr Riley be appointed in substitution.
5. The Applicant be released as Administrator in respect of those companies on Appendix 4 pursuant to Section 20 of the Act.
6. The Applicant be removed as Administrator of the companies in administration on Appendix 5 pursuant to paragraph 88(1) of Schedule B1 to the Act ("the Schedule") and that Mr Riley be appointed in substitution.
7. The Applicant has his discharge pursuant to paragraph 98(2) of the Schedule in respect of those companies on Appendix 5.
8. The Applicant be removed as Trustee in Bankruptcy of the Bankrupts on Appendix 6 annexed hereto pursuant to Section 298 of the Act and that Mr Hellard be appointed in substitution.
9. The creditors be notified of the removals and appointments made herein by the placing of a single advert in the London Gazette, such advert to be placed within 28 days of the making of the Order herein. Any creditor who wishes to review the Order made be at liberty to apply to the court within 28 days of the advertisement. This advertisement is sufficient notice to all persons of the making of the order.
10. The costs of and occasioned by this Application be born by each of the cases referred to on the Appendices as an expense therein save that that the costs attributable to each case shall not exceed 10% of the realisations in that case. Where

there are insufficient funds available in any case, the costs will be attributable to those matters where such funds are available.

11. There be permission as required for each of the Appointments to be transferred back to the court in which each appointment was effective immediately prior to the hearing of the Application.
