BUSINESS REVIEW:




The Company did not trade during the current or preceding financial years and has made neither a profit nor loss, nor any recognised gain or loss.


The directors acknowledge their responsibilities for complying with the requirements of the Act with respect to accounting records and the preparation of financial statements.
