#### 1. The Financial Conduct Authority (FCA)

The FCA is the independent watchdog that regulates financial services. Use this information to decide if our services are right for you.

#### 2. Whose products do we offer?

We are an insurance intermediary only able to offer products from The Equine and Livestock Insurance Company Limited (ELICO). We arrange the policy with ELICO on your behalf. You do not pay us a fee for doing this. We receive commission from ELICO which is percentage of the total annual premium.

#### 3. Which service will we provide you with?

- We will advise and make a recommendation for you after we have assessed your needs.
- You will not receive any advice or a recommendation from us for insurance. To identify your demands and needs we may ask some questions to narrow down the selection of products that we will provide details on. You will then need to make your own choice about how to proceed.

We will act as agent of ELICO for the purpose of receiving and holding premiums and premium refunds in respect of ELICO policies. Premiums paid to us in relation to ELICO policies shall be treated as having been paid to ELICO and premium refunds from ELICO received by us for your benefit shall not be treated as having been paid by ELICO until we have paid them to you.

#### 4. What will you have to pay us for our services?

- Fees may become payable for default on a premium payment, policy alterations, replacement documentation, policy cancellation and reinstatement.

#### 5. Who regulates us?

E&L is a trading name of The Equine and Livestock Insurance Company Limited.

Complaints will be acknowledged within 5 working days. We will issue a final response within 8 weeks of receiving your complaint.

**7. Are we covered by the Financial Services Compensation Scheme (FSCS)?**

We are covered by the FSCS. You may be entitled to compensation from the scheme if we cannot meet our obligations. This depends on the type of business and the circumstances of the claim. Protection is at 100% where claims arise from the death or incapacity of the policyholder due to injury, sickness or infirmity. Protection is at 90% where claims arise under other types of policy with no upper limit. Further information about compensation scheme arrangements is available from the FSCS.
