# Sleep trial need to knows

1. Your 100 night sleep trial ends 101 days from when your new mattress arrives at your door, so you get the optimum amount of nights' sleep to try it out.
2. We think that by 50 nights, you'll have had a good amount of time to test your mattress properly, so we do encourage you to sleep on it for at least 50 nights - we can't accept it back before then.
3. If you want to send your mattress back to us (no hard feelings) contact our sleep team at [sleeptrial@mattressnextday.co.uk](mailto:sleeptrial@mattressnextday.co.uk) - we will want to see some photos of it in a clean, presentable condition.
4. For us to be able to accept a return, please have proof of purchase handy when contacting our sleep team (your order confirmation email will do). Bear in mind that any mattress return shipping costs will be your responsibility.
5. Only the person that bought the mattress can send it back for return, and please don't go taking it on holiday - the Sleep Trial only applies to mattresses that remain in the UK.
6. Feel free to remove all the original packaging from your mattress, but do make sure you use a mattress protector while you're testing it out. Remember, if you want to send it back to us, it must be in a clean and presentable condition.
7. Please don't go throwing your mattress down the stairs - the Sleep Trial won't apply to mattresses that are defective due to misuse or wilful damage (we know you wouldn't anyway).
8. And don't worry, we wouldn't dream of asking you to get it back in the box!
