Introduction

This document gives a static representation of some of the important metadata. It shows the top-level entities that can be queried from the API, and which metrics are deemed material for each sub-sector.

Both of these are subject to change and so may need to be checked against the date of this document.

For the API metadata, we also recommend querying the model dynamically - either with a query (as shown below) or with the interactive GraphQL tool as described in the API guide and shown in the examples.

Materiality

As mentioned in the Integrum ESG API guide, not all sustainability issues will be relevant for each company, which can be an issue when we want to capture data on key measures for every company.

Impact Metrics are present for all companies and include important measures on emissions, water consumption, and waste generation. So if we are looking for metric-level data for comparisons across diverse companies, it is better to use the Impact metrics below.

Impact Metric	Description
Wellbeing	Tax contributed to all governments
Resource Security	Waste generation
Decent Work	Number of jobs created by the company
Climate Stability	CO ₂ (and other GHG) emissions
Healthy Ecosystems	Water consumption
