



## POLICE REFORM AND SOCIAL RESPONSIBILITY ACT 2011

### The Elected Local Policing Bodies (Specified Information) Order 2011

#### Register of Interests of the **Deputy Police and Crime Commissioner**

#### Notification of Registrable Interests

---

In this notification:

“body in which the relevant person has a beneficial interest” means a firm in which the relevant person is a partner or a body corporate of which the relevant person is a director, or in the securities of which the relevant person has a beneficial interest;

“director” includes a member of the committee of management of an industrial and provident society;

“land” includes an easement, interest or right in or over land which does not carry with it a right for the relevant person (alone or jointly with another) to occupy the land or to receive income;

“elected local policing body” means the elected Local Policing Body to which the relevant person has been appointed;

“relevant period” means the period of 12 months ending with the day on which the relevant person makes an entry, amendment or deletion to the register of disclosable interests;

“relevant person” means the **Deputy Police and Crime Commissioner** for Cambridgeshire who is making the notification or disclosable interest set out below;

“securities” means shares, debentures, debenture stock, loan stock; bonds, units of a collective investment scheme within the meaning of the Financial Services and Markets Act 2000 and other securities of any description, other than money deposited with a building society.




