

Motionize Privacy Policy

This privacy policy (“**Privacy Policy**”) governs how we, Motionize Israel Ltd. (“**Player Maker**”, “**we**”, “**our**” or “**us**”), use Personal Information (defined below) that we collect, receive and store about individuals in connection with the use of: (i) the Player Maker software-as-a-service platform and related documentation, and features, as well as any fixes, updates or upgrades thereto (“**Software**”); (ii) the Player Maker mobile software application (“**App**”); (iii) the Player Maker sensors and any related equipment provided to you by Player Maker (“**Device**”), (i) - (iii) hereinafter referred to as the “**Services**”).

We do not ourselves host any of the Services. All hosting is done by third party service providers that we engage. This means that data you provide us or that we collect from you (including any Personal Information, as defined below), as further described in this Privacy Policy, is hosted with such third party service providers on servers that they own or control. Regardless of where such third party service providers are located (and some are located in the US), their servers may be located anywhere in the world (including the US). Your data may even be replicated across multiple servers located in multiple countries. So please be aware that you are consenting to your data being transferred to various third party service providers around the world (including the US).

1. **Introduction.** We have implemented this Privacy Policy because your privacy, and the privacy of other users, is important to us. This Privacy Policy explains our online information practices and the choices you can make about the way your Personal Information is collected and used in connection with the Services. “**Personal Information**” means any information that may be used, either alone or in combination with other information, to personally identify an individual, including, but not limited to, names, age, gender, position, training performance and physical performance, physical observations, schedule and assessments email address, a home or other physical address, or other contact information.
2. **Terms of Use.** This Privacy Policy forms part of our Service Terms and Conditions, which are available at: www.playermaker.co.uk/terms (“**Terms**”) and which any team which purchases the Services has agreed to, prior to accessing and/or using the Services for the first time. Any capitalized but undefined term in this Privacy Policy shall have the meaning given to it in the Terms.
3. **Consent.** You are not legally obligated to provide us Personal Information, and you hereby confirm that providing us Personal Information is at your own free will. By using the Services, you consent to the terms of this Privacy Policy and to our collection, processing and sharing of Personal Information for the purposes set forth herein. If you do not agree to this Privacy Policy, please do not access or otherwise use the Services.
4. **Modification.** We reserve the right, at our discretion, to change this Privacy Policy at any time. Such change will be effective 10 days following posting of the revised Privacy Policy on the Services, and your continued use of the Services thereafter means that you accept those changes.
5. **What Personal Information We Collect and How We Collect It.** We do not currently require you to provide Personal Information in order to have access to general information available on the Services. However, we do receive and/or collect Personal Information from you in the following ways:
 - 5.1. **Team Members.** As a Team Member uses the Services, we collect certain Personal Information of Team Members, such as, names, age, gender, position, training performance, physical performance, physical observations, schedule and assessments, which will be displayed to a Customer, and its Permitted Users, and analyzed by us in connection with the Services. You further agree that Permitted Users may have access to different features and functionalities of the App or the Software, as well as be exposed to different types of Team Member information via the Services, based on the Permitted User type in accordance with the available service offerings and the Data Access Permissions.
 - 5.2. **Account.** In order to access and use the Services, you may be required to create an account (“**Account**”). If you create an Account you will be required to provide us with certain information, such as your name, gender, age, email address, team name, telephone number, as well as a password that you will use for your Account (“**Account Information**”). You may also choose to provide additional Personal Information as part of the Account registration process and in connection with your ongoing use of your Account, such as your comments and notes regarding your Team Member. We may send you a text message to your mobile phone or an e-mail to the e-mail address you submit to confirm your registration. If you choose not to create an Account, you will not be able to access or use the Services. Regardless of which method you choose to register your Account, we may send an email to your nominated email address to instruct you how to confirm your registration.
 - 5.3. **“Contact Us” Information.** If you send us a “Contact Us” request, whether by submitting an online form that we make available on www.playermaker.co.uk or by sending an email to info@playermaker.co.uk, you may be required to provide us with certain information such as your name and email address and your Device serial number.
 - 5.4. **Log Files.** We may make use of log files. The information inside the log files includes internet protocol (IP) addresses, type of browser, Internet Service Provider (ISP), date/time stamp, referring/exit pages, clicked pages and any other information your browser may send to us. We may use such information to analyze trends, administer the Services, track users’ movement around the Services, and gather demographic information.

- 5.5. **Cookies and Other Tracking Technologies.** Our Services may utilize “cookies”, anonymous identifiers and other tracking technologies in order to for us to provide our Services and present you with information that is customized for you. A “cookie” is a small text file that may be used, for example, to collect information about activity on the Services. Certain cookies and other technologies may serve to recall Personal Information, such as an IP address, previously indicated by a user. Most browsers allow you to control cookies, including whether or not to accept them and how to remove them. You may set most browsers to notify you if you receive a cookie, or you may choose to block cookies with your browser.
- 5.6. **Location Data.** We may provide certain location-based services (“**Location Services**”) in connection with the Software and/or App that are dependent on data related to the geographic location of your mobile device on which the Software and/or App is installed (“**Location Data**”). If you choose to participate in these Location Services, you agree that we may collect or obtain your Location Data. You should be able to use the settings on your mobile device or personal computer to turn off location-sharing features.
- 5.7. **Google Analytics.** The Services may use a tool called “Google Analytics” to collect information about use of the Services. Google Analytics collects information such as how often users visit any site, what pages they visit when they do so, and what other sites they used prior to coming to the Services. We use the information we get from Google Analytics to maintain and improve the Services and our products. We do not combine the information collected through the use of Google Analytics with personally identifiable information. Google’s ability to use and share information collected by Google Analytics about your visits to the Software and/or App is restricted by the Google Analytics Terms of Service, available at <http://www.google.com/analytics/terms/us.html>, and the Google Privacy Policy, available at <http://www.google.com/policies/privacy/>. You may learn more about how Google collects and processes data specifically in connection with Google Analytics at <http://www.google.com/policies/privacy/partners/>. You may prevent your data from being used by Google Analytics by downloading and installing the Google Analytics Opt-out Browser Add-on, available at <https://tools.google.com/dlpage/gaoptout/>.
- 6. The Way We Use Personal Information.** If you submit or we collect Personal Information through the Services, then we may use such Personal Information in the following ways, via any applicable communication channel, including e-mail, SMS, Social Media, online forums etc.
- 6.1. We may use your Personal Information to send you marketing and/or advertisement communications that we believe may be of interest to you, to contact you in connection with the Services and certain programs or offerings that you may have registered for, and to identify and authenticate your access to the parts of the Services that you are authorized to access.
- 6.2. We will use your Personal Information to provide and improve our Services (including by analyzing any data obtained via the Services), such as by comparing your activity with that of other Team Members, including but not limited to performance, training routine, scores, performance etc.
- 6.3. We may use your designated email address to: (i) send you updates or news regarding the Services and our products; and/or (ii) respond to a “Contact Us” or administrative request (for example, to change your password).
- 6.4. We may transfer your Personal Information to our local or foreign subsidiaries or affiliated companies for the purpose of storing or processing such information on our behalf. Such information may be transferred to other countries. We require that these parties agree to process such information in compliance with our Privacy Policy.
- 6.5. We may share your Personal Information with our third party service providers and partners, but only to assist us with our business operations and to provide our Services to you and other users. Such information may be transferred to other countries. We use commercially reasonable efforts to only engage or interact with third party service providers and partners that post a privacy policy governing their processing of Personal Information.
- 6.6. We may disclose your Personal Information or any information you submitted via the Services if we have a good faith belief that disclosure of such information is helpful or reasonably necessary to: (i) comply with any applicable law, regulation, legal process or governmental request; (ii) enforce our Terms, including investigations of potential violations thereof; (iii) detect, prevent, or otherwise address fraud or security issues; or (iv) protect against harm to the rights, property or safety of Player Maker, our users, yourself or the public.
- 7. Use of Anonymous Information.** We may use Anonymous Information (as defined below) or disclose it to third party service providers in order to improve our Services and enhance your experience with the Services. We may also disclose Anonymous Information (with or without compensation) to third parties, including advertisers and partners. “**Anonymous Information**” means information which does not enable identification of an individual user, such as aggregated information about the use of our Services.
- 8. Opting Out.** You may choose not to receive future promotional, advertising, or other Services-related emails from us by selecting an unsubscribe link at the bottom of each email that we send. Please note that even if you opt out of receiving the foregoing emails, we may still send you a response to any “Contact Us” request as well as administrative emails (for example, in connection with a password reset request) that are necessary to facilitate your use of the Services.

9. **Choice.** At all times, you may choose whether or not to provide or disclose Personal Information. If you choose not to provide mandatory Personal Information, you will be unable to access the Services.
10. **Access/Accuracy.** To the extent that you do provide us with Personal Information, we wish to maintain accurate Personal Information. If you would like to delete or correct any of your other Personal Information that we may be storing, you may submit an access request by sending an email to info@playermaker.co.uk. Your email should include adequate details of your request.
11. **Links to and Interaction with Third Party Products.** The Services may enable you to interact with or contain links to your Third Party Account and other third party websites, products and services that are not owned or controlled by us (each a “**Third Party Service**”). We are not responsible for the privacy practices or the content of such Third Party Services. Please be aware that Third Party Services may collect Personal Information from you. Accordingly, we encourage you to read the terms and conditions and privacy policy of each Third Party Service that you choose to use or interact with.
12. **Children’s Privacy.** We do not enter into contracts with anyone we know to be under the age of 18 years old. However, in order to provide the Services, we may collect, retain and use Personal Information of Team Members who are under eighteen years old. If you are using the Services for the collection of Personal Information from children, you are required to obtain prior, written parental consent to the use, collection and retention of such data in accordance with Section 13 of the Terms. The Services are not structured to attract children under the age of 9 years. Accordingly, we do not intend to collect Personal Information from anyone we know to be under 9 years. If we learn that we have collected Personal Information from a child under 9 years, we will delete that information as quickly as possible. 13. **Security.** The security of Personal Information is important to us. We follow generally accepted industry standards, including the use of appropriate administrative, physical and technical safeguards, to protect the Personal Information submitted to us. However, no method of transmission over the Internet, or method of electronic storage, is 100% secure. Therefore, while we strive to use reasonable acceptable means to protect your Personal Information, we cannot guarantee its absolute security or confidentiality. 14. **Merger, Sale or Bankruptcy.** In the event that we are acquired by or merged with a third party entity, or in the event of bankruptcy or a comparable event, we reserve the right to transfer or assign Personal Information in connection with the foregoing events.
15. **California Privacy Rights.** California Civil Code Section 1798.83 permits our customers who are California residents to request certain information regarding our disclosure of Personal Information to third parties for their direct marketing purposes. To make such a request, please send an email to info@playermaker.co.uk. Please note that we are only required to respond to one request per customer each year
16. **Our California Do Not Track Notice.** We do not currently respond or take any action with respect to web browser “do not track” signals or other mechanisms that provide consumers the ability to exercise choice regarding the collection of personally identifiable information about an individual consumer’s online activities over time and across third-party web sites or online services. We may allow third parties, such as companies that provide us with analytics tools, to collect personally identifiable information about an individual consumer’s online activities over time and across different web sites when a consumer uses the Services.
17. **Deletion of Content from California Residents.** If you are a California resident under the age of 18 and a registered user, California Business and Professions Code Section 22581 permits you to remove content or Personal Information you have publicly posted. If you wish to remove such content or Personal Information and you specify which content or Personal Information you wish to be removed, we will do so in accordance with applicable law. Please be aware that after removal you will not be able to restore removed content. In addition, such removal does not ensure complete or comprehensive removal of the content or Personal Information you have posted and that there may be circumstances in which the law does not require us to enable removal of content.
18. **Commitment.** We are committed to protecting your privacy. Protecting your privacy online is an evolving area, and we are constantly evolving our Service to meet these demands.
