AFFIDAVIT

(By Clare Rewcastle-Brown In support of the Plaintiff's Application to strike out the 8th Defendant's Statement of Defence dated 06.11.2017 and to challenge the authority of Messrs Shafee & Co to act for the 8th Defendant)

I, Clare Rewcastle-Brown (U.K. Passport No. 517546875), a United Kingdom citizen of full age and residing at No. 2, Morpeth Terrace, London SW1P 1EW do hereby solemnly and sincerely affirm and state as follows:-

- 1. I am an independent investigative journalist publishing articles regularly in the Sarawak Report website.
- 2. I affirm this Affidavit in support of the Plaintiff's application to strike out the 8th Defendants Statement of Defence dated 06.11.2017 and also to challenge the authority of Messrs Shafee & Co to act for the 8th Defendant herein.
- 3. All facts deposed to herein are within my own knowledge and belief and where necessary, derived from documentation and personal notes to which I have constant access, save where the contrary is specifically stated.
- 4. I am familiar with the matter filed herein by the Plaintiffs. I have read and understood the contents of the Statement of Claim filed herein as I have been provided a copy.
- 5. I have also been in communication with the 8th Defendant herein (Deepak) since early 2013. This was after Deepak had given several press conferences in the later part of 2012 and had subsequently published a booklet called "The Black Rose", which was then available online.
 - I annex hereto a copy of the booklet titled "The Black Rose" which I downloaded from the internet in early 2013, as **Exhibit 'CRB-1'**.
- 6. In the press conferences Deepak gave towards the end of 2012 and early 2013, he confirmed the account Balasubramaniam A/L Perumal (PI Bala) (whose widow is the First and Second Plaintiffs herein) of his forced removal from Malaysia with his family and his retraction of the Statutory Declaration he had affirmed on the 01.07.2018 (SD1), replacing it with another Statutory Declaration dated 04.07.2008 (SD2).
- 7. In the subsequent four years we kept in touch but rather superficially.

- 8. In or about June 2016, Deepak contacted me to discuss the situation he was in, in respect of the First case filed by PI Bala's wife, Selvi. He indicated that he was prepared to reveal what he termed 'explosive material' in those proceedings but was apprehensive about the repercussions this would lead to.
- 9. It was for this reason Deepak reached out to me in the hope that I would use my good relations with some Malaysians I knew who held high positions, who would be prepared to support him once he revealed the information he was referring to. He erroneously assumed that I had close connections with Tun Dr. Mahathir. I advised him that he was probably in a better position to approach Tun Dr. Mahathir than I was.
- 10. Thereafter, Deepak kept in constant touch with me through SMS hoping to receive positive news on a potential meeting with Tun Dr. Mahathir but I informed him I was really in no position to arrange a meeting as requested. I did however make whatever enquiries I could to help Deepak but I did not succeed in putting Deepak in touch with Tun Dr. Mahathir directly.
- In the course of the conversations I had with Deepak at the time, he informed me of the essence of his situation and of the information in his possession.
- 12. He explained that he had not contested Selvi's Appeal to the Court of Appeal against the Order of the High Court striking out her First case because to do so would conflict with his previous public remarks to the press in late 2012/early 2013.
- 13. He was afraid this would not auger well if he were to be cross-examined on these press statements as they were all true. He said that he could not deny what he had said publicly.

- 14. During my several communications with Deepak I got the impression that he was genuinely remorseful about what had happened to PI Bala and his family. He readily admitted to me that this was not right.
- 15. He then explained to me why he had joined the other Defendants in Selvi's First suit in having it struck out at the Federal Court level after he had conceded to the Appeal in the Court of Appeal.
- 16. I took notes of the communications and conversations I had been having with Deepak from the time he first contacted me. According to these notes, to which I now make reference, Deepak explained that he had been forced to accept Tan Sri Shafee Abdullah (Shafee) as his solicitor and counsel in the First suit after he had been put under pressure by the Inland Revenue Board to pay huge taxes they said were due from him and his company in respect of property gains tax.
- 17. He informed me that the personality involved in arranging the appointment of Shafee as his lawyer then was a gentleman known as Dato Azeez who apparently held a high position in Tabong Haji and was very close to the Prime Minister and his wife. The person Deepak referred to is one Dato Abdul Azeez Bin Abdul Rahim, the Member of Parliament for Baling.
- 18. Deepak further informed me that Shafee's fees were being paid by the Prime Minister, Najib Razak, through Dato Azeez, who was acting as the 'facilitator', a term Deepak used.
- 19. Deepak also informed me that he was concerned that he may have been induced to sign some Affidavits by Shafee in return for relief on the tax bills he was faced with, and that the contents of these Affidavits were untrue. He had been instructed to deny allegations made against him which were in fact true and which had previously been revealed by him personally and recorded in audio visual format by Harakah and Malaysiakini.

- 20. Once again, according to my notes, on the 26.08.2016, Deepak had sent an email to Shafee terminating his appointment as his lawyer. Apparently this was done 3 days before Deepak's Appeal was to be heard in the Federal Court.
- 21. According to Deepak, Shafee refused to be terminated and wrote him a letter that same day informing him of the consequences if he was. Negotiations were then entered into that weekend involving Deepak, Dato Azeez and Shafee. Deepak was promised his tax liabilities would be resolved and had apparently received a letter to that effect. That is why he re-engaged Shafee to represent him that Monday morning (29.08.2016) when his Appeal came up for hearing in the Federal Court.
- 22. I understand that Deepak's Appeal was allowed and Selvi's First case effectively came to an end.
- 23. However, Deepak later informed me that the deal went sour because the Minister of Finance wrote him a letter saying that they did not agree to the terms of the settlement referred to in paragraph 21 hereof. Deepak told me he felt that they wanted to "keep him hanging with a noose around his neck".
- 24. Deepak provided me with evidence that Shafee & Co had been badgering him to sign Affidavits as early as February 2016, which he refused to sign as the contents were not true. I believe these Affidavits were to do with Deepak's Appeal to the Federal Court against the decision of the Court of Appeal allowing Selvi's Appeal.

I annexe hereto a copy of a screen shot of an SMS exchange between Tan Sri Shafee Abdullah and Deepak on the 15.02.2016 indicating the involvement of Dato Azeez as a go-between, as **Exhibit 'CRB-2'**.

- 25. Deepak was once again in touch with me around the middle of 2017. He complained that his tax issues had not been solved and wanted to meet with me to reveal everything that had gone on. We were in the process of arranging a meeting when unfortunately both his parents passed away in July 2017.
- 26. Deepak contacted me once again on the 20.10.2017. This was just a few days before he was due to submit his Statement of Defence in Selvi's Second suit. He told me he was resisting the pressure to engage Shafee & Co again. Apparently he had discharged them from acting for him in Selvi's Second suit a couple of weeks earlier.
- 27. Deepak further said he was adamant that the truth would come out this time in the defence he was preparing and that he had been played out previously. He explained that the tax bills he was facing were as a result of some land deals he had done on behalf of Rosmah Mansor (the Second Defendant herein) and it was she who had taken all the profits. So by right she should have been liable for the tax and not him.
- 28. Deepak told me he had the assistance of legal counsel helping him draft his Statement of Defence and that they had been working on it all night. If I am not mistaken, this was on the 24.10.2017. Deepak informed me that he would send me a copy of his defence when he had completed it.
- 29. At about 6.30 p.m. (UK time) on the 24.10.2017, I received an email from Americk Sidhu forwarding an email he had received from Deepak. The attachment to this email was the Statement of Defence Deepak had prepared in both Bahasa and English. It was dated the 25.10.2017. Americk told me he had been instructed by Deepak to forward that email to me.
- 30. I did not hear from Deepak after that, although he had tried to call me on two occasions. These were missed calls from his phone number. Several

days later I heard that Deepak had engaged the services of Shafee & Co once again, who had filed a Statement of Defence completely different from the one Deepak had sent me via Americk a few days earlier.

- 31. I am affirming this Affidavit because I believe that Deepak is under duress to cooperate with Shafee & Co as he faces overwhelming financial pressure as a result of an abuse of his tax situation by the authorities if he does not. I am convinced Deepak has been made to sign a completely different defence due to the financial pressure he is under and that Shafee is complicit in this.
- 32. I am equally convinced that Shafee is not acting in Deepak's best interests in this matter but has been appointed specifically to protect the interests of the First and Second Defendants.
- 33. My understanding is that the reason why Deepak has been in contact with me and has revealed much information is because he wants to make public the predicament he is in and is unable to do so himself due to the pressure exerted upon him as aforesaid.
- 34. I have always felt that Deepak is sincerely remorseful for the predicament he has unwittingly placed Selvi and her family in at the behest of the Prime Minister and his wife and is intent on making reparation to the family for this indiscretion. He has however been prevented from doing so by parties who have an interest in ensuring that he does not reveal the truth as this would affect those parties adversely.
- 35. In the circumstances, I believe that the true defence intended to be used in this case is the one Deepak sent to Americk on the 25.10.2017 and not that defence filed by Shafee on the 06.11.2017.
- 36. I also firmly believe that Deepak has not, of his own free will, engaged the services of Shafee & Co, who have obviously been appointed by other

parties who have much to lose if Deepak were allowed to tell the truth in this matter.




