Dear Student and Parent

Following the Prime Minister's address on 22 September 2020 and the new restrictions that are to be implemented in England, we are taking some further actions to mitigate the risks of COVID-19 infections. These are important as we continue to prioritise the health and safety of our staff and students. We are also taking these actions to minimise the impact and disruption to the learning and working of others following any confirmed cases.

Therefore, from Monday 28 September:

- Face coverings or visors are to be worn indoors at all times by staff and students (unless you are working on your own / independently away from others)

IMPORTANT – Students must notify college if:

- You have COVID symptoms

We are awaiting further guidance on whether there are further mitigations and actions we need to take following the new restrictions. Your tutors will discuss these with you should the need arise.

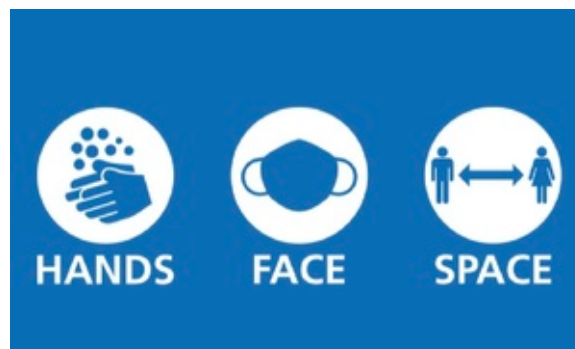
