**CLOSING OF MANAGEMENT TRANSFER AGREEMENT**

---

*Unless otherwise defined, all capitalised terms used in this announcement which are not defined herein shall have the same meanings ascribed to them in the announcement in relation to the Management Transfer Agreement dated 11 December 2025.*

The Board of Directors of The Trendlines Group Ltd. ("**Trendlines**" or the "**Company**" and, together with its subsidiaries and associated companies, the "**Group**") wishes to announce that on 29 January 2026, the Board of Directors of Trendlines have closed the management transfer deed (the "**Agreement**") between Trendlines Agrifood Fund Pte. Ltd. (the "**Fund**"), and Proterra Investment Advisors (Singapore) Pte. Ltd. ("**Proterra**") as previously announced on 11 December 2025 ("**11 December Announcement**").

All required conditions were met, including receipt of unanimous investor consent and completion of regulatory and administrative requirements. Accordingly, the transfer of management of the Fund to Proterra has been completed.

Following completion, Proterra has assumed full responsibilities as the sole investment manager of the Fund, and Trendlines Agrifood Innovation Centre Pte. Ltd. has retired from its role as the investment manager of the Fund. The Fund will be renamed **Proterra Trendlines Fund Pte. Ltd.**, and the relevant governance changes have taken effect.

The Board believes that this transition supports Trendlines' strategic focus on its core activities and positions the Fund and its portfolio companies to benefit from Proterra's sector expertise and global network. Additionally, this agreement enables Trendlines to benefit from the performance of the Fund through Proterra's management as stated in the 11 December Announcement.
