Prior to 18 June 2026, Geneva Holdings Company (GHC) SA ("GHC") was wholly owned by Pod Sàrl ("Pod"). GTC and Pod undertook a merger transaction pursuant to which the assets and liabilities of Pod were assumed by GHC. The merger was effected on 18 June 2026 and Pod ceased to hold any interest in GHC from thereon. Pod was subsequently dissolved on 25 June 2026 and no longer exists.

Librae Holdings Limited ("LH") has direct interests in 393,072,899 shares in the capital of The Trendlines Group Ltd. The entire share capital of LH is held by Geneva Trust Company (GTC) S.A. ("GTC") as Trustee of The Tchenguiz Three Trust (the "Trust"), the sole discretionary beneficiary of which is Mr. Vincent Tchenguiz.

As Trustee of the Trust, GTC has the authority to dispose of, or to exercise control over the disposal of, the Trust's assets, which includes the entire share capital of LH and the shares held by LH in the Trendlines Group Ltd.

GTC is a wholly owned subsidiary of Geneva Holdings Company (GHC) SA ("GHC") which in turn is wholly owned by Pod Sàrl for which Mr Rodney Hodges holds 100% of the share capital.

Following the merger of Pod Sàrl with GHC which became effective on 18 June 2026, GHC became 100% directly owned by Mr Rodney Hodges. Please also refer to section 13 below in relation to the merger and the ownership of GHC.

Librae Holdings Limited ("LH") has direct interests in 393,072,899 shares in the capital of The Trendlines Group Ltd. The entire share capital of Librae Holdings Limited ("LH") is held by Geneva Trust Company (GTC) S.A. ("GTC") as Trustee of The Tchenguiz Three Trust (the "Trust"), the sole discretionary beneficiary of which is Mr. Vincent Tchenguiz.

Prior to 18 June 2026, Geneva Holdings Company (GHC) SA ("GHC") was wholly owned by Pod Sàrl ("Pod"), which is in turn wholly-owned by Mr Rodney Hodges. GHC and Pod undertook a merger transaction pursuant to which the assets and liabilities of Pod were assumed by GHC. The merger was completed on 18 June 2026 and Pod ceased to hold any interest in GHC from thereon. Pod was subsequently dissolved on 25 June 2026 and no longer exist as at the date of this notification. Prior to the merger, Mr Rodney Hodges fully-owned Pod and further to the merger, GHC is directly wholly-owned by Mr Rodney Hodges.

None of Mr Rodney Hodges, Pod, GHC or GTC has any beneficial interest in the shares in The Trendlines Group Ltd. owned by LH, which is owned by the Trust, the sole discretionary beneficiary of which is Mr. Vincent Tchenguiz.

Mr Rodney Hodges is the owner of GTC, a third party service provider providing trustee services and has no beneficial interests in the shares in The Trendlines Group Ltd. owned by LH, and Mr Rodney Hodges has been complying with substantial shareholding notifications applicable to him. The merger of GHC and Pod is part of the internal group restructuring of Mr Rodney Hodges's personal assets, and the failure to timely report the percentage change to Pod's deemed interests in the shares of The Trendlines Group Ltd. held by LH was a result of inadvertent oversight following the internal group restructuring.

The percentage of shares held before and after the change is calculated based on The Trendlines Group Ltd.'s total number of issued shares (excluding treasury shares and subsidiary holdings) of 1,455,493,553 shares as at 18 June 2026.
