If you fail to return the equipment to us, we are entitled to charge you for the cost of such equipment in accordance with our Residential T&Cs. Your contract will start on the day our services are activated. This gift card is offered in conjunction with the current offer on 24-month contracts only. The Amazon.co.uk gift card is not applicable on 12-month contracts.
